

## **Grand Farm Privacy Policy**

Grand Farm ("we," "our," or "us") values your privacy and is committed to protecting your personal information. This Privacy Policy explains how we collect, use, and share information about you when you visit our website, grandfarm.com (the "Site"), and engage with our programs, events, and services.

#### 1. Information We Collect

We may collect the following types of information about you:

- **Personal Information:** When you sign up for our newsletter, register for events, participate in projects or field trials, apply for partnerships, donate, or contact us, we may collect personal information such as your name, email address, phone number, mailing address, organization, job title, and payment information.

- Google Analytics Advertising Features: Grand Farm may enable Google Analytics Advertising Features, including:
  - Remarketing with Google Analytics
  - Google Display Network Impression Reporting
  - Google Analytics Demographics and Interest Reporting
  - Integrated services that require Google Analytics to collect data via advertising cookies and identifiers

#### 2. How We Use Your Information

We use the data collected for purposes including:

- Enhancing website functionality and user experience
- Personalizing content and providing targeted advertisements
- Analyzing traffic patterns and visitor demographics to improve our services
- To send you newsletters, updates, promotional materials, and other communications related to our services.
- Comply with legal and regulatory obligations



#### 3. How We Share Your Information

We do not sell or rent your personal information to third parties. However, we may share your information with:

- **Service Providers:** Third-party vendors who assist us in operating our Site, conducting our business, and providing services to you.
- **Legal Requirements:** If required by law or in response to legal processes, such as a court order or subpoena.
- Business Transfers: In the event of a merger, acquisition, or sale of all or a portion of our assets, your information may be transferred to the new owner.

### 4. Regional and Global Privacy Compliance

- **United States:** We comply with applicable U.S. privacy laws and regulations, including relevant state-level consumer privacy requirements.
- **European Union:** If you are located in the EU, we comply with applicable data protection laws, including GDPR. Where required, consent banners and opt-in mechanisms are used for cookies and analytics. Consent banners will appear to provide opt-in mechanisms for cookies and analytics usage.
- Japan: For users in Japan, non-personally identifiable information is handled in accordance with the applicable laws, and any data processing is performed only after obtaining legally required consent.

### 5. Data Security

We take reasonable measures to protect your personal information from unauthorized access, use, or disclosure. However, no internet or email transmission is ever fully secure or error-free.

You have the following choices regarding your personal information:

- Mailchimp: When you subscribe to our newsletter or provide your email address
  through our website, your information is stored and processed by Mailchimp, an email
  marketing service. Mailchimp helps us manage email subscriptions, send
  communications, and analyze engagement with our emails. By subscribing, you consent
  to your data being stored and processed by Mailchimp in accordance with its <a href="Privacy">Privacy</a>
  Policy.

We use the information collected through Mailchimp to:

- Send newsletters, event updates, and other communications.
- Analyze engagement with our emails (e.g., open rates, link clicks) to improve our messaging.

You may unsubscribe from our emails at any time by clicking the "unsubscribe" link in the footer of any email you receive from us.

### 7. Third-Party Links
